**Guidelines:**

1. It is agreed that the hosted party will pay \$100 nonrefundable deposit to secure the pool rental upon signing of the contract. If the hosting party breaks this agreement through cancellation or any other means, the deposit will be forfeited. Deposits will not be refunded for in-climate weather.
2. All food and beverage, alcohol or otherwise, must be purchased through Grazi. Light snacks, a cake and nonalcoholic drinks may be brought into the pool area.
3. Lifeguards are assigned to the pool based on expected attendance. Should your guest exceed the guest count, Oxford Athletic Club reserves the right to limit the number of users in the pool or charge an additional fee for additional lifeguards.
4. Hosting party agrees to inform Oxford 10 days in advance of the event date of the definite number of guests. Hosting party agrees to be financially responsible for the rental fee for number of guests.
5. The event must end at the designated time above. If the use of the pool exceeds the specified above, an additional charge \$100 per half hour will be charged.
6. Oxford Athletic Club must approve the use of props, decorations, and other such equipment prior to use of facility.
7. Amplified music of any kind will not be permitted.
8. Oxford Athletic Club is not held responsible for damaged or stolen property or personal injury to any person during the hosting party's use of facility.
9. Advanced access for the purpose of decorating/setting up will be discussed one week prior to the event date and will be based on pool closing times.
10. For security purposes, all guests must enter through the assigned entrance and exit through the same door.

11. Guests are permitted to use the bathrooms. Guests will not be permitted to use the locker rooms or Club towels.
12. The event must remain in the pool area. Guests will not be permitted to use any other area of the Club. Offenders will be asked to exit the party immediately.
13. Hosting party will be responsible for any damages that may be caused due to inappropriate behavior.
14. American with Disabilities. Oxford Athlete Club is proud to able to comply with the ADA and to make accommodations to allow individuals with disabilities to attend and to participate in Club events. If the hosting party or any event guests require such accommodations, please alert the Club at least 10 days before the event, if possible.
15. Right to terminate contract for offensive or dangerous behavior. Oxford Athletic Club, as a private club, retains the rights to terminate any events and/or ask an event guest(s), including members, to leave the facility, when Oxford Athletic Club, in sole direction finds the event or guest(s) to be offensive and/or dangerous for any reason, including, but not limited to, drunkenness, abusive behavior or language, rowdiness, etc.
